Count I. Failure of Mandated Reporter to Report (3638499.0)

The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, **Robert W. Finn**, in violation of Section 210.115, RSMo, committed the **Class A Misdemeanor of Failure of Mandated Reporter to Report**, punishable under Section 558.011.1(5) RSMo, in that on or between December 16, 2010 and May 11, 2011, in the County of Jackson, State of Missouri, the defendant was a mandated reporter and had reasonable cause to suspect a child may be subjected to abuse due to: previous knowledge of concerns regarding Father Ratigan and children; the discovery of hundreds of photographs of children on Father Ratigan's laptop, including a child's naked vagina, upskirt images and images focused on the crotch; and violations of restrictions placed on Father Ratigan; and knowingly failed to immediately report such suspected abuse to the Missouri Children's Division.

Count II. Failure of Mandated Reporter to Report (3638499.0)


